In the event that Creditor institutes court proceedings to recover any amount due to us, we undertake to pay legal costs as between attorney and client, all disbursements and collection commission that the Creditor may be charged by its legal practitioners. The costs to be recovered by the Creditor shall not be affected by the choice of forum selected by the Creditor.
